An Act to place a cap on moneylenders' interest rates, by amending the Consumer Credit Act 1995; and to provide for related matters. 5

**Be it enacted by the Oireachtas as follows:**

## **Short title, collective citation and commencement**

1. (1) This Act may be cited as the Consumer Credit (Amendment) Act 2022.
- (2) The Consumer Credit Acts 1995 to 2010 and this Act may be cited together as the Consumer Credit Acts 1995 to 2022. 10
- (3) This Act comes into operation six months after the date of its passing or on such earlier date or dates than the said six months as the Minister may by order appoint and different dates may be so appointed for different purposes and different provision.
